## MAGIC 102.5 "CHELSEA HANDLER LITTLE BIG B\*@TH" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station KTCX-FM ("Station"), 2615 Calder Ave Suite 706, Beaumont, Texas 77702, during available business hours Monday through Friday, on the Station website www.KTCXcom, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the KTCX MAGIC 102.5 "CHELSEA HANDLER LITTLE BIG B\*@TH" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last THIRTY (30) DAYS or a prize valued at \$500 or more in the last THIRTY (30) DAYS and whose immediate family members or household members have not won a prize from the Station in the last THIRTY (30) DAYS or a prize valued at \$500 or more in the THIRTY (30) DAYS Void where prohibited by law. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. 2. Contest Period. The Contest entry period will begin at 12:01 am CT on November 1 and will run through 11:59 pm CT on Friday, November 8th, 2024 (the "Contest Period"). The Station's computer is the official timekeeping device for this Contest.

## 3. **How to Enter.**

On-Air: Listen to the Station weekdays during the Contest Period. When the Station plays the "cue-to-call" sounder, listeners must call the Station at (409) 838-1025. Caller TEN (10) to the The Station, as determined by the Station in its sole discretion, will be entered for a chance to win. Time Delay Between Over-the-Air Analog Signal and Internet Broadcast: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to The Station online may hear the cue to call later than listeners listening to the Station's analog over-the air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

- 4. Winner Selection. Once each weekday during Middays (10am-3pm CT) November 1<sup>st</sup>- November 8th, 2024. Station will select ONE (1) potential winner(s) via phone number of (409) 838-1025 received by Station during the Contest Period. Each winning entrant will be gathered for prize distribution (subject to verification of eligibility and compliance with the terms of these rules). The Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
